At least one public sector individual (excluding the individual being nominated for the award) must be the nominator or an additional reference. Please be sure to complete all questions.

The deadline for 2023 award submissions is Monday, May 15, 2023. Questionnaires must be completed by that date. Incomplete submissions will not be considered.

The award will be presented at the NCSEA 2023 Leadership Symposium, August 6-9, 2023 in Anaheim, California.
