

2024 NCSEA New Leader Scholarship Application

1. Scholarship & Nominee Information

The NCSEA New Leader Scholarship is offered for the 2024 Leadership Symposium, August 4-7, 2024, in Detroit, Michigan.

The NCSEA New Leader Scholarship shall be awarded to anyone within the child support community who has been a leader for two years or less, and who is demonstrating outstanding potential to improve his or her team's performance. The scholarship includes:

- Leadership Symposium registration
- Three nights hotel lodging (August 4, 5, & 6, 2024)
- Travel expenses not to exceed \$500.
- One-year NCSEA Individual membership

Applicants must submit a statement (500 words) on how the applicant would utilize information and networking gained in the course of attending the Leadership Symposium, including how he/she would then share that information upon return to the agency. In addition to the statement, the applicant's supervisor is required to submit a letter of recommendation as well as a statement that, if chosen, the applicant will be able to travel out-of-state to the NCSEA 2024 Leadership Symposium August 4-7, in Detroit, Michigan.

The deadline for 2024 scholarship applications is Friday, May 3, 2024. All documentation and forms must be submitted by that date. Incomplete submissions will not be considered.
