In addition, the improvement is recognized as exemplary, that is, one to be emulated by others.

If the nominator is NOT the State or Tribal IV-D Director, or the County or local director, he/she must indicate whether they have shared the recommendation with the appropriate agency director. At least one public sector individual (excluding the individual being nominated for the award) must be the nominator or an additional reference. Please be sure to complete all questions. The deadline for 2024 award submissions is Friday, May 10, 2023. Questionnaires must be completed by that date. Incomplete submissions will not be considered.

The award will be presented at the NCSEA 2024 Leadership Symposium, August 4-7, 2024, in Detroit, Michigan.
