The NCSEA Emerging Leader Award recognizes an emerging leader or manager (fewer than 3 years in a leadership position) that has improved a child support program or has enhanced the child support program in its mission in the last year. In addition, the improvement is recognized as exemplary, that is, one to be emulated by others.

If the nominator is NOT the State or Tribal IV-D Director, or the County or local director, he/she must indicate whether they have shared the recommendation with the appropriate agency director. At least one public sector individual (excluding the individual being nominated for the award) must be the nominator or an additional reference. Please be sure to complete all questions. The deadline for 2025 award submissions is Friday, May 9, 2025. Questionnaires must be completed by that date. Incomplete submissions will not be considered.

The award will be presented during the NCSEA 2025 Leadership Symposium, August 11-14, 2025, in Atlanta, Georgia.
